# WEBSITE TERMS OF USE

# 1. INTRODUCTION

- 1.1 Thanks for visiting the website owned by Broadwick Venues Limited which operates and manages Depot Mayfield, whether via our website or mobile application (we'll refer to them collectively as our "Website" for short) brought to you by Depot Mayfield (we, us or our).
- 1.2 These Website Terms of Use (the **Terms**), together with our **Privacy Policy and Cookies Statement (**the **Privacy and Cookies Policy)** sets out the terms that apply to your use of our Website and any content therein (or **Content**).
- 1.3 In these Terms, when we refer to **you** and **your** we mean you, the person using or visiting our Website.
- 1.4 If you are under the age of 18, please make sure that a parent or legal guardian (Adult) reads these Terms and explain any sections to you that you don't understand. You must have an Adult's permission to use the Website and unfortunately only an Adult can set up accounts with us and make purchases with us.

### 3. BY USING OUR PLATFORM YOU ACCEPT THESE TERMS

By visiting our Website you agree to be bound by these Terms so please ensure that you read these Terms carefully. If you do not agree to all of these Terms, do not access or use the Website.

#### 4. ACCESS TO AND USE OF THE WEBSITE

- 4.1 There is currently no charge for your use of the Website, although you will of course be charged for any tickets or other goods and/or services that you purchase through the Website. - 9.3.1.4likely to deceive any person; 9.3.1.5uploaded in breach or any legal duty owed to any third party, such as a duty of confidentiality; 9.3.1.6promoting of any illegal activity;
- 9.3.1.7threatening, abusive or invasive of another person's privacy, or likely cause annoyance, inconvenience or needless anxiety;
- 9.3.1.8 likely to harass, upset, embarrass, alarm or annoy any other person;
- 9.3.1.9 impersonating any person or misrepresenting your identity or affiliation with any person; or
- 9.3.1.10giving the impression that it emanates from us, if this is not the case.
- 9.4 You warrant that any User Content you upload to the Website complies with our Content Standards and agree to indemnify us for any breach of this promise. This means that you will be responsible for any and all loss or damage that we suffer as a result of your failure to comply with this promise.
- 9.5 You grant us and other users of the Website, a non-exclusive, royalty free, transferable, sub licensable, worldwide licence to use, store, copy, host and distribute via the Website any User Content that you upload to the Website.
